Camping Guide

Campers Onus Applies:

All campers using the Chinese Gardens camping ground accept the risks associated with bush camping and indemnify the Walhalla Board of Management Inc., Parks Victoria, the Department of Environment Land Water & Planning and Baw Baw Shire Council from all risks and claims.

Sites South Side

- 2 wheel drive access
- Sites are allocated on check-in.
- Sites are approximately 70 square metres
- Maximum site occupancy of 4 adults (16 years and over), or two adults and 4 children under 16 years old.
- Small caravans can be accommodated on some sites; please enquire when you book. The remainder are tent or camper trailer access only.
- Camps must remain within the allocated site boundary.
 - Do not spread into an adjacent site or onto the vehicle access areas.

North Side

- 4 wheel drive access only.
 - Access is by a ford crossing Stringer's Creek.
- Sites are not allocated.

General

- Permits must be shown on your vehicle while within the camping ground.
- Only one vehicle per site.
 - Additional vehicles must be left parked by the access road adjacent to the amenities block.
- For the comfort of other campers, please ensure that noise is reduced to a minimum between 10 pm and 8 am.
 - No generators between 10 pm and 8 am.

Fires must comply Department of Environment Land Water & Planning requirements: *[insert a link here to <http://www.depi.vic.gov.au/fire-and-emergencies/public-land-fire-restrictions/campfires-and-barbeques> Call the link "Campfire Safety"]*

- No Fires are to be lit or to remain alight on days of Total Fire Ban.

- It is up to the camper to be aware when a day of Total Fire Ban is declared.
- Do not cut down any vegetation within the Chinese Gardens and adjacent creek area. Penalties apply for cutting down of native vegetation.
- Campfires are permitted as long as you observe the following conditions:
 - The ground and airspace within a distance of 3 metres from the outer perimeter and upper most point of the fire are clear of flammable material.
 - The fire pit to be a minimum of 30 cm deep.
 - The fire does not occupy an area exceeding 1 square metre in any direction.
 - All dimensions of solid fuel are less than 1 metre.
 - Fires must be under the control of an adult (minimum of 16 years of age).
 - Fires must not be left unattended.
 - Fires must be completely extinguished with water when unattended.

Please use the provided toilet amenities.

- Bush Toileting is not permitted.
- Showers require a \$1 coin to activate for 4 minutes.

Pets must be under the owners control at all times.

- Ensure your pet is not a nuisance to other campers.
- Pick up after your dogs and place droppings in a fire pit or bin it.
- Do not leave your dogs droppings for others to find.
